Whereas the authorization committee has considered the medical certificate from the treating physician of **Fortis Hospital, Sector 62, Phase-VIII Mohali** certifying that the recipient is suffering from chronic kidney failure and requires kidney transplantation for survival.

And whereas the committee has gone through the facts and circumstances of donation from a live donor. Now therefore in exercise of the powers conferred to it by clause (i) section 2 of the Transplantation of Human Organs Act, 1994, the authorization committee does not approve for the kidney transplantation between the above mentioned donor and recipient at Fortis Hospital Sector 62, Phase-VIII Mohali **in view of the following issues:-**

Although the case falls in the category of love and affection as per the Human Organ Transplant Act, but there is nothing to suggest love and affection between donor and recipient as per the statements recorded in the authorization committee meeting. The donor is working as an employee with the recipient's family. Moreover, the complete health status and kidney status of the donor has not been revealed to him though mentioned in the submitted record.
