"The Executive Committee of the Council considered the assessment reports (08th December, 2017 and 29th & 30th January, 2018) and decided to recommend to the Central Government for recognition/approval of Guru Gobind Singh Medical College, Faridkot for the award of MBBS degree granted by Baba Farid University of Health Sciences, Faridkot against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 23.02.2018.

The report of virtual assessment is not available with the UGMEB. The physical assessment report was considered in the Undergraduate Medical Education Board, an autonomous Board of the Commission.

2. While evaluating the assessment report alongwith the AEBAS and HMIS data including CCTV, following was observed:

Deficiency in Faculty and Resident as observed on AEBAS record:

Total working days assessed: 08

The faculty and Senior Resident Doctor deficiency is calculated on the basis of attendance of registered persons by the college on AEBAS records. The attendance of these faculty is ranging from zero to less than 50% of the total working days.

Out of 204 persons registered, 45 have zero attendance and 62 have less than 50% attendance.

- 3. After careful consideration, it has been decided by the Under Graduate Medical Education Board (UGMEB) that Guru Govind Singh Medical College, Farikot, Punjab is granted one year recognition to the MBBS qualification with the direction to the college authorities to rectify the shortcomings/deficiencies mentioned above.
