I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Compliance Verification Assessment Report (13/06/2016 (02 seats)) along with the Council Assessor's Report (June, 2014 (for 2 seats) and 13/06/2016 (for 2 to 4 seats)) and compliance dated 12/05/2015 submitted by the college authorities on the physical and other teaching facilities available at Guru Govind Singh Medical College, Faridkot for the award of MD(Microbiology) qualification for 04 seats under Baba Farid University of Health Sciences, Faridkot. Baba Farid University of Health Sciences, Faridkot *vide* its letter No.06-BFUHS(Colleges-C3)/2022/C-1486 dated 4th June, 2022 had requested National Medical Commission to conduct inspection of Guru Gobind Singh Medical College, Faridkot for renewal of three recognised seats (2, 2 to 3) and for recognition against increased intake of four seats (3 to 7) of MD (Dermatology, Venereology & Leprosy) qualification in respect of students being trained at the medical college, having an annual intake capacity of seven seats in the said course.

2. WHEREAS, the Post-Graduate Medical Education Board (PGMEB) got the assessment of Guru Gobind Singh Medical College, Faridkot done on 8th February, 2023 for verification of infrastructure, clinical material, faculty for all-round training of students as per curriculum requirement. On scrutiny of the Assessment Report and other records, the Post-Graduate Medical Education Board (PGMEB) found the following deficiencies:

- i. Inadequate number of units and inadequate number of beds in the Department for the seven PG seats;
- ii. Low bed occupancy;
- iii. Non-availability of laser machine in the Department;
- iv. Inadequate number of journals and non-availability of latest journals in the Departmental library;

3. WHEREAS, the deficiencies stated in **para 2 above** were pointed out to the said medical college *vide* PGMEB Letter No.35/652(35)/2022-PGMEB/012535 dated 16th March, 2023 and the medical college was given an opportunity to submit a written explanation in respect of the deficiencies. The said medical college furnished the reply *vide* letter No.Trg/2023/8387 dated 13th April, 2023. The Compliance Verification Report, furnished by the said medical college, was placed before the Post-Graduate Medical Education Board. The Board observed that the medical college has accepted that they have one unit with thirty beds with sufficient faculty for three post-graduate seats. Similarly, the medical college has informed that the procurement of laser machine and journals for the departmental library has been initiated.

4. WHEREAS, the responsibility of determination and maintenance of standards of post-graduate medical education is entrusted upon the Post-Graduate Medical Education Board of the National Medical Commission as per National Medical Commission Act, 2019 (NMC Act, 2019), Post-Graduate Medical Education Regulations-2000 (PGMER-2000) and Maintenance of Standards of Medical

Education Regulations, 2023 (MSMER-2023). Further, Section 6.2 of the PGMER-2000 and Section 8(1) and (2) of the MSMER-2023, stipulate imposition of penalty(ies) on the medical college/institution, if they fail to comply with any statutory provisions.


5. WHEREAS the medical college has failed to comply with the requirements and has compromised with the quality of medical education. Considering the non-availability of equipment, inadequate journals and non-availability of latest journals, inadequate number of units and beds, low bed occupancy which is adequate for three post-graduate seats; the Post-Graduate Medical Education Board has decided to renew recognition of three seats of MD (Dermatology, Venereology and Leprosy) and to reduce the annual intake capacity in the course of MD (DVL) from the existing seven to three from the Academic Year 2024-2025. Hence, the break-up of MD (DVL) seats in the medical college will be as indicated below:

However, the students admitted by the medical college till the Academic Year 2023-2024 will not be affected by this reduction of seats and their post-graduate degrees will be considered recognised for the purpose of registration of the degree awarded by the University.

The Baba Farid University of Health Sciences, Faridkot had applied for **renewal of recognition of five (5) seats of MS (Orthopaedics)** qualification in respect of students being trained at the **Guru Govind Singh Medical College, Faridkot**, having an annual intake capacity of **five seats** in the said course.

2. WHEREAS, the Post-Graduate Medical Education Board (PGMEB) got the assessment of the **Guru Govind Singh Medical College, Faridkot** done on **14th June, 2023** for verification of infrastructure, clinical material, faculty for all-round training of students as per curriculum requirement. On scrutiny of the Assessment Report and other records, the Post-Graduate Medical Education Board (PGMEB) found the following deficiencies:

- The beds in the Department of orthopaedics are inadequate as per MSR-2020;
- Deficiency of one Assistant Professor; and
- Inadequate surgical load in the Department.

3. WHEREAS, the deficiencies stated in **para 2 above** were pointed out to the said medical college *vide* PGMEB Letter No.35/652(40)/2022-PGMEB/049778 dated **4th September, 2023** and the medical college was given an opportunity to submit a written explanation in respect of the deficiencies. The said medical college furnished the reply *vide* Letter No.Trg/2023/28923 dated **22nd November, 2023**. The Compliance Verification Report, furnished by the said medical college and the Aadhaar Enabled Biometric Attendance System (AEBAS) of the **Department of Orthopedics** for the period **01.08.2023 to 23.11.2023** were placed before the Post-Graduate Medical Education Board. The Board found that there is deficiency of faculty and Senior Resident in the Department as per the aforesaid AEBAS report. Further, it was observed that the OP clinical workload and surgeries in the Department were inadequate not only on the day of inspection but also as per the average of random three days and annual data of the entire year **2022**. Hence, the Board felt that the clinical workload and surgeries were inadequate for the annual intake of **five PG seats** (fifteen PG students studying at a given time). Therefore, the reply furnished by the medical college was not found satisfactory and acceptable by the Board.

4. WHEREAS, the responsibility of determination and maintenance of standards of post-graduate medical education is entrusted upon the Post-Graduate Medical Education Board of the National Medical Commission as per National Medical Commission Act, 2019 (NMC Act, 2019), Post-Graduate Medical Education Regulations-2000 (PGMER-2000) and Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023). As per **A.1.15 of Schedule-I** of the Minimum Requirements for Annual M.B.B.S. Admissions Regulations, 2020, installation of Aadhaar Enabled Biometric Attendance System (AEBAS) is mandatory and NMC has been advising the medical colleges/institutes to install the Aadhaar Enabled Biometric Attendance System (AEBAS) from time to time. With a view to

effectively implement the AEBAS, NMC vide its letter No.D-130024/07/2022/NMC/DMMP dated 1st August, 2022 issued instructions to all medical colleges/institutions to install AEBAS devices for biometric attendance. Further, **Section 6.2** of the PGMER-2000 and Section 8(1) and (2) of the MSMER-2023, stipulate imposition of penalty(ies) on the medical college/institution, if they fail to comply with any statutory provisions.


5. WHEREAS the medical college has failed to comply with the requirements and has compromised with the quality of medical education. **Considering the deficiency of faculty, low surgeries and low OP clinical workload in the Department of Orthopaedics, which is not adequate to train the PG students studying in the medical college, the Post Graduate Medical Education Board has decided to grant recognition to four seats of MS (Orthopaedics); and to reduce the annual intake capacity in the course of MS (Orthopaedics) from the existing five to four seats from the Academic Year 2024-2025.** Hence, the break-up of MS (Orthopaedics) seats in the medical college will be, as indicated below:

Baba Farid University of Health Sciences, Faridkot vide its letter No.01 BFUHS(Colleges-C3)/2022/C-1486 dated 4th June, 2022 had requested National Medical Commission for conduct of inspection of Guru Gobind Singh Medical College, Faridkot for recognition against increased intake of seven seats (4 to 11) of MS (General Surgery) qualification in respect of students being trained at the medical college, having an annual intake capacity of eleven seats in the said course.

2. WHEREAS, the Post-Graduate Medical Education Board (PGMEB) got the assessment of Guru Gobind Singh Medical College, Faridkot done on 8th February, 2023 for verification of infrastructure, clinical material, faculty for all-round training of students as per curriculum requirement. On scrutiny of the Assessment Report and other records, the Post-Graduate Medical Education Board (PGMEB) found the following deficiencies:

- i. Deficiency of sixteen beds in the department as per the norms of MSR-2020
- ii. Inadequate beds for eleven PG seats;
- iii. Inadequate OPD clinical load;
- iv. Deficiency of one Assistant Professor
- v. Medical Superintendent was a faculty of Forensic Department;
- vi. There is no office for the Surgery Department -- Ward's Room is being used as HoD's Room and office
- vii. Teaching Room in the OPD had inadequate capacity and there was no audio-visual;
- viii. Senior Residents of Surgery also perform duty at Civil Hospital Jalalabad and Advance Cancer Institute, Bhatinda;
- ix. Elective and Emergency cases are inadequate;
- x. On the day of assessment, no laboratory services were available in Casualty;
- xi. Casualty Operation Theatre was not in the Casualty Complex; and
- xii. Latest editions of General Surgery book and journals were not available.

3. WHEREAS, the deficiencies stated in **para 2 above** were pointed out to the said medical college vide PGMEB Letter No.35/652(31)/2022-PGMEB/013152 dated 17th March, 2023 and the medical college was given an opportunity to submit a written explanation in respect of the deficiencies. The said medical college furnished the reply vide letter No.Trg/2023/8382 dated 13th April, 2023. The Compliance Verification Report, furnished by the said medical college, was placed before the Post

Graduate Medical Education Board. The reply furnished by the medical college in respect of inadequate OP workload, elective and emergency cases, Medical Superintendent holding the faculty position in Forensic Department, non-availability of lab services in the Casualty, non-availability of OT in the Casualty Complex, shortage of sixteen beds and shortage of one Assistant Professor was found incomplete, unsatisfactory and unacceptable by the Board as the medical college had not addressed all these deficiencies.

4. WHEREAS, the responsibility of determination and maintenance of standards of post-graduate medical education is entrusted upon the Post-Graduate Medical Education Board of the National Medical Commission as per National Medical Commission Act, 2019 (NMC Act, 2019), Post-Graduate Medical Education Regulations-2000 (PGMER-2000) and Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023). Further, Section 6.2 of the PGMER-2000 and Section 8(1) and (2) of the MSMER-2023, stipulate imposition of penalty(ies) on the medical college/institution, if they fail to comply with any statutory provisions.

5. WHEREAS the medical college has failed to comply with the requirements and has compromised with the quality of medical education. Considering the inadequate OP clinical workload, inadequate number of beds, inadequate infrastructure, which is just adequate for eight post-graduate seats; the Post-Graduate Medical Education Board has decided to recognise eight seats of MS (General Surgery) and to reduce the annual intake capacity in the course of MS (General Surgery) from the existing eleven to eight from the Academic Year 2024-2025. Hence, the break-up of MS (General Surgery) seats in the medical college will be as indicated below:
