Form of the bond to be executed for the purpose of a two-year service to the government after the completion of the MBBS degree course by a student who is a major, i.e., above 18 years of age, or by the guardian of a student who is a minor, i.e., below 18 years of age, admitted to the MBBS degree course, with two Sureties.

I, Director-Principal of \_\_\_\_\_ Medical College, \_\_\_\_\_, hereby inform the student and jointly and severally bind ourselves, our sureties, our respective heirs, executors, administrators, and legal representatives to the Governor of Punjab (hereinafter referred to as "the Government") in the sum of Rs. 20,00,000/- (Rupees Twenty Lakhs Only) payable to the Government on demand. WHEREAS the Government Medical College in the state offers a Bachelor of Medicine and Bachelor of Surgery (MBBS) degree course. The student shall:

- (i) Complete the MBBS course at the college to which they are admitted or any other recognized Government or Private Medical College in the State of Punjab, including any transfer admissions.
- (ii) Complete the prescribed internship and obtain the MBBS degree.

(iii) If required/offered by the Government, serve the Government of Punjab/Rural Service or any local authority as directed by the State Government for a minimum period of two years for State Quota students, as per Government of Punjab Corrigendum No. (E723871)MER-HTH305C/9/2024/5HB3/I/1125449 dated 13.06.2025 and can be extended as desired by the Government.

**NOW, THE CONDITIONS OF THE ABOVE WRITTEN BOND ARE AS FOLLOWS:**

- (i) The student shall diligently pursue and complete the MBBS course at the said college in the State of Punjab and strictly comply with the rules of the Government. If the student is granted migration/transfer from one college to another after the 1st year examination, they shall adhere to the rules of the new college and complete the course.
- (ii) Upon passing the final examination and completing the internship, the student shall, within 30 days, inform the Director, Medical Education and Research, Punjab and offer themselves for Government/Rural Services. If called upon, the student shall serve the Government for two years in the prescribed grade and remuneration.
- (iii) During the period of service, the student shall faithfully discharge their duties as assigned and observe the applicable rules and regulations.

**IT IS HEREBY AGREED AS FOLLOWS:**

- (a) In the event of a breach of any of the above terms and conditions, the total sum of Rs. 20,00,000/- (Rupees Twenty Lakhs Only) shall become payable by the student's guardian and/or the sureties, jointly and severally, and may be recovered by the Government as arrears of land revenue.
- (b) If the student becomes ineligible for Government service due to misconduct, indiscipline, or other reasons, they shall be liable to pay the bond amount and any additional penalty determined by the Government.
- (c) The Government is not obligated to inform the student before initiating action to recover the due amount from the guardian or sureties.

(d) The liability of the sureties under this bond shall not be discharged for any reason.

(e) If a student intends to pursue postgraduate studies immediately after completion of the MBBS course, they shall mandatorily inform the Director-Principal of the college before applying for NEET-PG and shall obtain a "No Objection Certificate" (NOC) from the Director-Principal/Director, Medical Education & Research (DMER) prior to taking admission. In case the student secures admission to a postgraduate course within the State of Punjab, the applicable State PG bond conditions shall apply in full. However, if the student secures admission outside the State of Punjab, they shall be permitted to complete their MBBS bond service obligation after completion of the postgraduate course. Notwithstanding this, the State reserves the right to invoke and enforce the MBBS bond conditions at any appropriate stage, in accordance with applicable rules and circumstances. Further, if the student fails to complete the postgraduate course within five years of admission or abandons it, the conditions of the bond shall immediately become applicable.
